To Whom it May Concern,

Enclosed is a copy of the Public Notice of Application. The site plans, summary report and technical reports completed in support of a licence application for the subject site as required in the provincial standards made under the Aggregate Resources Act are available in a digital format using the link provided. A hard copy of the site plans and/or summary report with technical reports are available upon request.

The application is for a Class "A" licence, pit above the water table for 21.8 hectares of land within the subject property located in the Township of Malahide. The application is for a new pit with a proposed annual tonnage limit of 200,000 tonnes. The proposed final rehabilitation is agriculture.

The Ministry of Natural Resources and Forestry has determined the application package to be complete on December 6, 2023 and has given the applicant permission to continue with the public notification and consultation process described in the provincial standards. The 60 day notification period will begin on January 3, 2024 with publication of the Public Notice of Application in the Aylmer Express on that day.

We will be hosting an information session on January 17, 2024 from 4:30 to 6:00 pm. as noted in the Public Notice of Application.

After March 4, 2024, it will be deemed that there are no objections with the licence application.
